Quail Court our self-pay rates have dipped below the Medicaid levels and our increasing our level 2 and level 3 rates, starting August 1 st , we will be charging the residents for personal care items. The staffing level is double what the actual level should be. Several hospitals in the state are looking at layoffs. Looking at different models to help with not having to lay off people.
